- 1. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.
 - Bids will be opened in the presence of the bidders' representatives who choose to attend at the Office of the City Mayor Conference Room, City Hall, Zamboanga City.
- 8. Bidders are required to indicate the validity period of their bids in the Bid Form. Failure to indicate the same shall be considered that the bid is valid for a period of 120 calendar days as specified in Section 28.1 of the Revised Implementing Rules and Regulations of R.A. No. 9184.
