



INVITATION TO Re-BID FOR

Construction of Health Center / Construction of Multi-Purpose Pavement (Cluster) (Name of Project)

1. The CITY GOVERNMENT OF ZAMBOANGA, through the **General Fund (AB FY -2012 & FY -2008)** intends to apply for Re-Bid with the sum of **TWO MILLION THREE HUNDRED FOURTEEN THOUSAND PESOS (P2,314,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Health Center / Construction of Multi-Purpose Pavement (Culanan and Putik)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CITY GOVERNMENT OF ZAMBOANGA now invites bids for **Construction of Health Center / Construction of Multi-Purpose Pavement which involves layout and excavation, embankment, soil poisoning/termite control, reinforcing steel, structural concrete, masonry works, septic vault, steel works, septic vault, steel works, light steel framing system, roofing works, carpentry and joinery works, doors, windows, grilleworks, plumbing works, ramp railings, electrical works, tile works, concrete masonry units, painting works, sub-grade preparation, aggregate sub-base course, portland cement concrete pavement, corss drain and line canal**. Completion of the Works is required in **One Hundred Thirteen [113]** calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested Bidders may obtain further information from the Office of the City Mayor-Procurement, Acquisition and Award Division (PAAD) and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM starting **April 13, 2012 to May 03, 2012**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P2,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
6. The City Government of Zamboanga will hold a Pre-Bid Conference on **April 20, 2012 at 10:00AM** at the Office of the City Mayor Conference Room, City Hall, Zamboanga City, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **May 03, 2012 at 10:00AM** at Office of the City Mayor Conference Room, City Hall, Zamboanga City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the Office of the City Mayor Conference Room, City Hall, Zamboanga City.

8. Bidders are required to indicate the validity period of their bids in the Bid Form. Failure to indicate the same shall be considered that the bid is valid for a period of 120 calendar days as specified in Section 28.1 of the Revised Implementing Rules and Regulations of R.A. No. 9184.

All bids must be accompanied by a bid security in the form of cash, cashier's /manager's check, bank draft/guarantee confirmed by a Universal/Commercial Bank, Irrevocable Letter of Credit issued by a Universal/Commercial Bank or from other bank certified by the Bangko Sentral ng Pilipinas as authorized to issue such financial instrument, provided however that it shall be confirmed or authenticated by a Universal/Commercial Bank if issued by a foreign bank in the amount of **P46,280.00** or Surety Bond callable upon demand issued by a Surety or Insurance Company duly certified by the Insurance Commission as authorized to issue such security in the amount of **P115,700.00** or any combination of the foregoing in the amount proportionate to share of form with respect to total amount of security.

Equipment to be used: Plate Compactor, Bar Cutter, Bagger Mixer, Concrete Vibrator, Acetylene/Oxygen Outfit, Welding Machine, Electric Sander, Electric Drill, Electric Planer, Walk Behind Roller and Concrete Cutter

Key Personnel: Project Manager, Project Engineer, Material Testing Engineer, Pest Controller / Applicator and Foreman.

9. The City Government of Zamboanga reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
